# What is Healthy Schools Certification?



#### **Overview of Healthy Schools Certification**

The Healthy Schools Approach engages the whole school community to promote and enhance the health and well-being of children, youth, school staff, and the broader community. Healthy Schools Certification is based on a 4-Step Healthy Schools Process, inspired by the <u>Canadian Healthy School Standards</u> and <u>Canada's Comprehensive School Health Framework</u>. This process helps a school to plan and implement a range of activities that promote well-being in the school community, focusing on health topic(s) that are important to the school. Through a point-based system, over the course of the school year, schools will be able to plan their Healthy Schools process steps online and apply for Gold, Silver, or Bronze certification.

#### **Goals of Healthy Schools Certification**

Healthy Schools Certification is guided by the following goals:

- To support schools that want to enhance the health and well-being of their students and staff
- To increase student engagement and leadership opportunities to support health and well-being at school
- To increase adult engagement in prioritizing health and well-being at school
- To strengthen community engagement and partnerships

# What is Healthy Schools Certification?



#### **Healthy Schools Areas**

Healthy Schools Certification awards points to schools that plan and run activities in four key areas:

- Teaching and Learning: Teaches students about your selected health topic(s) through curriculum
- Social & Physical Environment: Improves social relationships (e.g., student to staff) and/or enhances your school's physical environment (e.g., play spaces) in your school
- Policy: Supports school health policy (or policies) connected to your selected health topic(s) (e.g., Healthy Eating Policy)
- Partnerships & Services: Enhances partnerships and services with school and community partners and/or students' families

Note: These areas are closely connected to Canada's Comprehensive School Health Framework, the Canadian Healthy School Standards, and Ontario's Foundations for a Healthy School.

Planning activities relating to these four areas will help schools, school boards/districts/authorities, parents/caregivers<sup>1</sup>, and community partners<sup>2</sup> (including public health) work together to take a comprehensive approach to address health topic(s) in their school community.

## 4-Step Healthy Schools Process



Healthy Schools Certification program is based on a 4-step process that supports school communities to take a planned and comprehensive approach to address health topic(s) over the course of a school year.

#### These 4 steps include:

- **Step 1:** Assemble Your Team
- **Step 2:** Identify Your School Community Priorities, Assets, and Health Topic(s)
- Step 3: Develop Your Plan and Take Action
- Step 4: Celebrate and Reflect

Note: The number of health topics selected by schools has no impact on certification levels (e.g., schools that select multiple health topics do not receive more points than schools that choose one health topic).

#### **Register Your School**

Visit the Healthy Schools Certification <u>website</u> to register your school and set up your school's online dashboard. Only school staff can register their school. The deadline for registration is Friday, November 24, 2023, at 10:00 a.m. (MT), 12:00 p.m. (ET), 1:00 p.m. (AT).

# How Can My School Get Certified?



#### Complete Healthy Schools Process Steps 1–4 and Report

Steps 1–4 must be completed through the online dashboard by Friday, May 3, 2024, at 10:00 a.m. (MT), 12:00 p.m. (ET), 1:00 p.m. (AT). Schools can report on activities occurring after May 5, provided they are scheduled prior to submitting for certification.

Important: Schools that do not meet this timeline will not be eligible for certification as timelines cannot be extended.

#### **Receive Your Certification Results**

School certification results will be communicated at the end of May. Schools that are certified will receive a banner with their certification level.

#### Remember:

- ✓ All reporting needs to be done using the online dashboard
- All reporting must be completed by Friday, May 3, 2024, at 10:00 a.m. (AT), 12:00 p.m. (ET), 1:00 p.m. (AT)
- ✓ All 4 steps must be completed to be eligible for certification

#### **Levels of Certification**

Healthy Schools Certification has been developed using a point-based system aligned with the 4-Step Healthy Schools Process.

There are three levels of certification:

- Gold (400-450 points earned)
- Silver (350-399 points earned)
- → Bronze (300-349 points earned)

Note: Schools that complete all 4 Steps and receive fewer than 300 points will be recognized as a certified school, but will not receive Gold, Silver, or Bronze certification level. These schools will still receive a banner recognizing their efforts.

# How Can My School Get Certified?



#### **Reporting Requirements**

Reporting Requirements to earn points toward certification vary across each process step. In some instances, teams are only required to provide basic information (e.g., Yes or No answers) to earn points while, in other cases, additional information is required to demonstrate your work.



In cases where additional information is required, this icon will be included to indicate that supplementary content must be provided (e.g., specifically written responses).

#### **Healthy Schools Support Tools (HSST)**

We have developed Healthy Schools Support Tools that may be used by schools participating in Healthy Schools Certification. These tools have been developed to support schools implement each process step. However, schools participating in Healthy Schools Certification are not required to use the support tools available.

Schools are encouraged to develop formal plans (using the Healthy Schools Plan Template or another planning tool), but only high-level information about school activities are required for reporting.

#### **School Reporting Audit Process**

In May, an audit will be conducted of all information submitted by schools through their online dashboard. Points for each component of each step are all or nothing, meaning there are no part marks. Upon audit, a school will not receive a higher certification level than the one they submitted for. Following the review process, a school may receive a lower certification level than the one applied for if the reporting information provided was insufficient. All information submitted is reviewed multiple times and any reduction in level is made through consensus of the audit team. All results are final.

Once a school's certification level has been audited, schools will receive communication confirming their Healthy Schools Certification results (e.g., their level). All schools certified at any level will receive a banner with their certification level. Schools can prominently display the banner in their school to celebrate their achievements!

# 4-Step Healthy Schools Process



#### **Purpose**

The 4-Step Healthy Schools Certification Process offers consistency in the approach teams take to build their healthy school. Since Healthy Schools Certification is based on a school's ability to follow the process, it is adaptable for all of the unique school communities across Canada. Each process step serves a specific purpose in becoming a healthy school.

#### **Point Values**

- Step 1: Assemble Your Team (90 points)
- Step 2: Identify Your School Community Priorities, Assets, and Health Topic(s) (120 points)
- → **Step 3:** Develop Your Plan and Take Action (200 points)
- → **Step 4:** Celebrate and Reflect (40 points)

## Step 1: Assemble Your Team



Step 1 involves bringing together members of your school community to form your team and learning about the Healthy Schools Approach and process steps with your team members. This team includes a Healthy Schools Lead (a staff member from the school who agrees to oversee the team) and should also include a combination of students, other school staff members, principal/vice-principal, parents/caregivers, and/or community partners (including public health).

By the end of Step 1, your school will have established a team committed to making your school a healthier place. This team can always add members as you proceed through Steps 2-4.



Note: Many schools already have existing teams or classes with a common purpose aligned with Healthy Schools, such as a Student Leadership class, a Safe and Accepting Schools Team, or a Positive School Climate Team. We encourage schools to leverage these teams to avoid duplication.



# Step 2: Identify Your School Community Priorities, Assets, and Health Topic(s)



Step 2 involves working with your team to better understand the priorities and assets of your school to help inform which health topic(s) should be your focus for this school year.

School priorities are determined by collecting/locating data (e.g., from surveys, focus groups, interviews) from different members of your school and community to understand which health topic(s) to focus on. Once you have identified your priorities, you will work with your team to identify the top assets (e.g., people, programs, places) that your school currently has in place to support addressing your priorities. You will use this information to help identify your health topic(s).

By the end of Step 2, your team will have located/collected key information relating to your school's priorities and assets and decided on your health topic(s) for the school year.

#### **Canadian Healthy School Standards**

A resource created by the Canadian Healthy Schools Alliance with the purpose of sparking the conversation about Healthy Schools in Canada. It can serve as a checklist for those on their Healthy Schools journey or in a nonlinear manner wherever it is needed.

#### Canada's Comprehensive School Health Framework

An internationally recognized framework that focuses on a whole-school approach for student academic achievement and health. This framework recognizes four areas in their Healthy Schools Approach that are consistent with the Healthy Schools Certification areas: teaching and learning, social and physical environment, policy, and partnerships and services.

### **Glossary**



#### **4-Step Healthy Schools Process**

A process that supports school communities to take a planned approach to address health topic(s) in their school. These 4 steps include:

- Step 1: Assemble Your Team
- Step 2: Identify Your School Community Priorities, Assets, and Health Topic(s)
- Step 3: Develop Your Plan and Take Action
- Step 4: Celebrate and Reflect

#### **Administration**

The principal and/or vice-principal(s) of a school.

#### **Community Partner**

Any member of the school community who can contribute to the development of a healthy school (e.g., public health, recreation and sport groups, municipalities, local businesses). These partners may vary depending on the specific school community.

#### **Data Source**

Sources of information used by school communities to identify their priorities (included in Step 2 of Ophea's 4-Step Healthy Schools Process).

#### Health Topic(s)

The health topic(s) identified by a school community (e.g., healthy eating, mental health) to be addressed through their Healthy Schools activities for the school year.

#### **Healthy Schools Approach**

A collaborative approach whereby members of the school community come together to share ideas, plan, and take action on health topic(s) while following a repeatable, step-by-step process to make sustainable change in their school, homes, and community.

#### **Healthy Schools Areas**

The four interconnected areas that school communities should consider in their plan to comprehensively address their health topic(s): Teaching & Learning; Social & Physical Environment; Policy; Partnerships & Services.

### Glossary



#### **Healthy Schools Lead**

The Healthy Schools Lead is the school staff member who will lead their school through Healthy Schools Certification. The Healthy Schools Lead is the key contact at the school who ensures that the Healthy Schools Certification registration and reporting are completed online. This position is decided by the school, not by Ophea. The Healthy Schools Lead is the main contact for Ophea and must be an employee of the school.

#### **Healthy Schools Support Tools (HSST)**

These are a series of downloadable tools that were created to support schools in completing the 4-Step process successfully. They are all available online through each registered school's online dashboard and are customizable to each school's needs. Schools are encouraged to complete them and use them if they support their work. However, <u>none of the HSST are mandatory</u>.

#### **Parents/Caregivers**

Parents and caregivers include all caring and care-giving members in the lives of students. This could include but is not limited to parents, grandparents, aunts/uncles, siblings, and guardians.

#### **Public Health**

Schools are supported by a system of local public health units that collectively cover the entire province and are individually responsible for serving the population within their geographic borders. Public health can play a key role in supporting school communities as it relates to Healthy Schools.

#### School Board/District/Authority

A school board, district or authority is responsible for the oversight of a number of schools within a geographical region and meets the needs of their school communities. The terminology used is dependent on Canadian region.

#### **Team**

A group or committee operating in a school that supports planning and action as it relates to Healthy Schools. Members of the team should include individuals who are within (e.g., students, educators, support staff) and outside (e.g., public health, parents/family members) the physical school grounds.
